## CONDITIONS ARE SET OUT BELOW

### GENERAL GUIDELINES

- 1 The JUDGING PANEL shall comprise no less than three persons assembled annually by the Chairperson of Buller Electricity Limited in consultation with local BEL Directors.
- 2 There shall be EITHER ONE PANEL to cover all Awards OR A SEPARATE JUDGING PANEL for each of the classes of Awards.
- 3 The decisions of the Selection Panel(s) shall be FINAL AND BINDING.
- 4 To ensure that there shall be MAXIMUM coverage of the acknowledgement of service and achievement, whilst still limiting the Awards to the numbers stipulated, NO PERSON OR SINGLE GROUP shall receive MORE THAN ONE AWARD in any one year.
- 5 An Individual or Group receiving a Pulse NBS Annual Community Contribution Award may **not** be nominated for an Annual Community Contribution Award and considered for selection in the following or subsequent ten-year timeframe.
- 6 UNSUCCESSFUL NOMINEES may be renominated in the year following or any subsequent years.

### Annual Community Contribution Award

This purpose of the award is designed to recognise and honour everyday people making a positive difference doing extraordinary things in the Buller community. The annual community contribution award recognises community groups, organisations or individuals for their achievements and contribution to their communities, with special focus over the last 12 months. The successful recipient/recipients will share a strong sense of community spirit and have played a vital role in the social, cultural, environmental, or economic prosperity in the Buller District. The aim of the award is to recognise their efforts as they make our communities stronger, more vibrant and promote community spirit.

The judges will consider the following when reviewing the nomination:

- Include a profile of the individual, community/group or organisation and the services provided
- Describe who has benefited and benefits from the results of the work of this individual, community/group or organisation
- How does the work/community contribution of the nominee positively impact the Buller community or the cause they are working toward
- Have there been any challenges they have had to overcome
