GENERAL GUIDELINES

- 1 The JUDGING PANEL shall comprise no less than three persons assembled annually by the Chairperson of Buller Electricity Limited in consultation with local BEL Directors.
- 2 There shall be EITHER ONE PANEL to cover BOTH Civic and Sporting Awards OR A SEPARATE JUDGING PANEL for each of the two classes of Awards.
- 3 The decisions of the Selection Panel(s) shall be FINAL AND BINDING.
- 4 To ensure that there shall be MAXIMUM coverage of the acknowledgement of service and achievement, whilst still limiting the Awards to the numbers stipulated, NO SINGLE PERSON OR GROUP shall receive MORE THAN ONE AWARD in any one year.
- 5 A person or group receiving a Civic Award may **not** be a previous recipient in the prior ten years.
- 6 UNSUCCESSFUL NOMINEES may be renominated in the year following or any subsequent years.

CIVIC AWARD

- 1 The Award is intended to provide TANGIBLE RECOGNITION OF OUTSTANDING VOLUNTARY SERVICE over a period of time and can embrace contribution in:

RECREATION AND SPORTS - YOUTH ACTIVITIES - SOCIAL WELFARE SERVICE -
EDUCATIONAL SERVICE - RELIGIOUS AND COMMUNITY AFFAIRS
- 2 Persons / Groups eligible for nomination shall have had active residence in the Buller district over a period of years but need not be presently residing in Buller.
- 3 Organisations and persons nominating candidates for an Award shall include the fullest possible outline of the nominee’s contributions in particular fields of activity, with details of term involvement and office held. SUCH INFORMATION IS ESSENTIAL to ensure the Selection Panel may fairly evaluate the qualifications of each individual nominee.
- 4 There shall be NOT MORE THAN THREE (3) Civic Honours Awards in any one year.
