GENERAL GUIDELINES

- 1 The JUDGING PANEL shall comprise three persons, selected by the organisers, of whom one shall be designated as “Chairman”
- 2 There shall be EITHER ONE PANEL to cover all Awards OR A SEPARATE JUDGING PANEL for each of the classes of Awards.
- 3 The decisions of the Selection Panel(s) shall be FINAL AND BINDING.
- 4 To ensure that there shall be MAXIMUM coverage of the acknowledgement of service and achievement, whilst still limiting the Awards to the numbers stipulated, NO SINGLE PERSON shall receive MORE THAN ONE AWARD in any one year.
- 5 A person receiving a Local Hero of the Year Award may **not** be nominated for a Local Hero of the Year Award and considered for selection in the following or any subsequent year.
- 6 UNSUCCESSFUL NOMINEES may be renominated in the year following or any subsequent years.

LOCAL HERO OF THE YEAR

The award is designed to identify and reward everyday people doing extraordinary things in our Buller community. We want to honour someone who is making a positive difference to the Buller District. Our local hero may be involved in business leadership, voluntary work, community and environmental groups, education, working with disadvantaged or have displayed courage in overcoming personal adversity.

The judges will consider the following when considering the nominations:

- A description of the initiative and leadership demonstrated by the individual
- What has this person done to inspire you to make this nomination
- How does the work/community contribution of the nominee positively impact the Buller community or the cause they are working towards
- Have there been any challenges they have had to overcome
