GENERAL GUIDELINES

- 1 Sport Tasman Young Sportsperson of the Year Award is open to candidates under the age of 20 years on October 15 2021.
- 2 Performance by candidates shall be considered only when they have occurred during the award for the year ending October 15 2021.
- 3 Candidates under consideration for awards must meet residential criteria under (a) or (b) below:
 - (a) Through residency in the Buller region for at least 12 months of the award period
 - (b) Through representing Buller in their chosen discipline during the award period
- 4 Awards seek to honour the highest standard of sport performance as well as expressing the ideals of fair play.

YOUNG SPORTSPERSON OF THE YEAR

In comparing performances, the judges shall adhere to the following scale of ranking except in exceptional circumstances:

- 1 Performance at national level ranks above performance at provincial level.
- 2 Performance at international level ranks above performance at national level.
- 3 Performance at international level may be compared through consideration of the international status of the sport eg a sport in which 60 countries are of elite international standard shall be considered ahead of one where only five countries are of elite standard (where performances are otherwise equivalent).
- 4 In general, a performance at international elite level by an individual shall outweigh a performance of similar standing for which an individual team member has been nominated.
(Team pertains to a team sport performance.)
